

# Privacy Policy

Protecting your private information is our priority. The Highland Medical Aesthetics website is a medical aesthetic clinic site. By using the Highland Medical Aesthetics website, you consent to the data practices described in this statement.

## Privacy Compliance Certification

Highland Medical Aesthetics has HIPAA and Protected Health Information Act certification.

This Practice will occasionally update this Statement of Privacy to reflect company and customer feedback. We encourage you to periodically review this Statement to be informed of how this Practice is protecting your information.

## Collection of your Personal Information

In order to better provide you with products and services offered, Highland Medical Aesthetics may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Medical Information

If you purchase Highland Medical Aesthetics's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Highland Medical Aesthetics may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or

other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

Highland Medical Aesthetics collects and uses your personal information to operate and deliver the services you have requested.

Highland Medical Aesthetics may also use your personally identifiable information to inform you of other products or services available from Highland Medical Aesthetics and its affiliates.

### **Sharing Information with Third Parties**

Highland Medical Aesthetics does not sell, rent or lease its customer lists to third parties.

Highland Medical Aesthetics may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Highland Medical Aesthetics may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. ### **Tracking User Behavior**

### **Automatically Collected Information**

## **Use of Cookies**

### **Children Under Thirteen**
